The diving boards and stands are being inspected in April. A new Weber grill has been procured and will be placed (and secured) to the pool deck concrete area near the kiddle pool. Prior to opening, the shallow end of the large pool will be drained and patched, the and showers in the women's bathroom will get new diverters and shower heads. The third shower stall wall will be patched and repainted.

If time permits - the front reception area will be updated with a new desk area and storage cabinets. A third "funbrella" is being considered for the slide-side of the main pool deck.

New tennis nets will be installed on Courts 1 and 3 this season, and all court lights will eventually be converted to the more energy efficient LED bulbs.

There are two new programs at Pinecrest: A men's team to compete in the Northern Virginia Tennis League (NVTL-Div.7C West), and we will be the host practice site for the Special Olympics NOVA team. Court reservations will be determined once activities resume.

The tennis courts are open year-round. We rely on players and their guests to help keep the courts clean and tidy. During the summer months, please use courtside trash and recycle bins. During the winter months, please take your trash home for proper disposal.

# Grounds & Maintenance — Mark Lewis

In 2019 we removed several dead and dying trees to both eliminate potential safety hazards and improve grounds aesthetics. Our contract with Palmers was up for review during the off-season. We solicited bids from four organizations and signed a contract with the top bidder, D'Gardens Lawn Care. I expect no lapse in service.

We expect yearly pothole patching as our parking lot continues to age - I expect at some point a re-paving of our lot will be necessary.

Due to financial constraints, we've deferred two projects: First, the addition of a playset for younger tikes (ages 2-5) next to the kiddie pool; and second, installation of a covered shelter next to the tennis courts to provide shade for the tennis players and shelter to wait for the occasional summer storm to pass.
